

# Applying for Affordable Housing



For Venture Housing to consider an application for affordable rental housing, you must have completed our online expression of interest (EOI) form <https://qrco.de/VH-EOI> and received an affordable housing registration number, with confirmation that you have met the minimum initial eligibility requirements. Should you be contacted about a suitable property, the following evidence must be provided when applying. It is recommended that you prepare and update this information regularly so that you can submit your application without delay if contacted.



## You will be required to supply:
